Dear Parents,

We are excited to let you know about our Summer School Program for this Summer! Registration opens March 3rd and is first come first served, depending on openings. You will be notified by email by the Preschool office once your registration is processed and your child has a spot in the program. You will be notified in June by your child's teacher introducing themselves.

Our program will run for eight weeks. You may register for the entire summer program or a four-week session separately. All Summer School classes will be held on the Rose Drive Little Friends Campus. A registration form is included in this email and we will also have forms available in both preschool offices.

Following are a few frequently asked questions about the summer program:

- Children will need to bring their own snack, lunch and water bottle to school each day. If your child will be staying for afternoon extended care, please send two snacks. When signing your student in, please put their snacks into the snack basket and their water bottle into the caddy for water bottles. Please be sure to mark the snack with your child's name as well as the water bottle, etc. For children staying for afternoon extended care, we are not allowing any "resting buddies" or blankets at this time. We do provide the mat, sheet and blanket for each child.
- Please send an extra set of school clothes in a labeled ziplock bag. This will stay in your child's cubby in case of an accident.
- Every student must be fully signed in and out daily (this includes time in, time out, parents name, and emergency phone number).
- If your child is feeling sick, please err on the side of caution and keep them home for the day. We appreciate your help with doing all we can to keep everyone safe and healthy! Please call the school office to let us know of your child's absence.
- Our facilities are being cleaned and sanitized nightly. Also during the day our staff are sanitizing toys, tables, play areas, etc.
- For children being dropped off before 8:00am, or picked up after 1:00pm, there is a phone number posted on the fence to call so that we can pick up your child, or bring your child to you.
- **Who may attend?** Current 2024-2025 students as well as new students who meet the FCS age requirements. New 2 year old students must be 2 by June 1st and fully potty trained. ALL students who attend summer school must be fully potty trained. We do not offer potty training for summer school.
- **Can we celebrate my child's summer birthday?** Yes you can! We are allowing birthday treats to be brought in but they must be store bought and individually wrapped by the manufacture for each child. Please check with your child's teacher about class allergies, etc.
- **May my child attend both sessions?** Children are welcome to attend both sessions. Each week will have a different theme so nothing will be repeated. You may register for the entire summer program at once with a non-refundable processing fee of \$50.00 or you may register for a single session with a non-refundable processing fee of \$25.00 per session. This fee is due at the time of your registration.
- **When is the first payment due?** The non-refundable processing fees are due at the time that you register your child. This fee can be charged through FACTS but must be paid within 10 days to hold the spot. If not paid, your child will be moved to a waitlist until it's paid. Tuition for the first session will be billed online through FACTS and will be due Wednesday, June 11, 2025. Tuition for the second session will be billed online through FACTS and will be due Wednesday, July 9, 2025. If you are not a current family and do not have a FACTS account, you will receive an email billing with these same due dates.
- **How is extended care billed?** Extended care is billed on an hourly basis (\$5.75 per hour or any part of an hour). You will receive an Extended Care bill online at the end of each month. Extended Care hours are 7:00am-9:00am & 1:00pm-6:00pm.
- **Do you take teacher requests?** By FCS policy, parents can not make requests for class placement.
